# on September 3, 2007 in Braunschweig

#### 1.) Administrative matters

#### 1.4 Approval of the agenda

The agenda as distributed was approved by general consent although the order was changed.

# 10) SV-Sieger Show 2007 Braunschweig

## 10.2.GHKL Bitches: Bernhard Norda

The judge of the Working Bitch class, Herr Bernhard Norda, intoduced the bitches in his class to whom he awarded the rating "V-Auslese".

## 10.1 GHKL Males: SV-Vereinszuchtwart Reinhardt Meyer

The judge of the Working Male class, Herr Reinhardt Meyer, intoduced the males to whom he awarded the rating "V-Auslese".

The representative of the German Shepherd Dog Club of Ireland arrived so the number of voting clubs was increased to 51.

# 2.) Report by the President of the WUSV and the General Secretary of the WUSV a.) WUSV

President Henke reported on the cooperation with the newly formed WUSV-Central Committee. Members include Herr Imran Husain (Pakistan), Herr Francisco Navarro-Reynoso (Mexico) and Herr Erich Orschler (Germany) who were named to two year terms.

The next meeting of the WUSV-Board will be on November 8, 2007. The Board will consider the development of new Bylaws and a new financial structure.

## b.) SV

President Henke reported on events in the the motherland of the breed. He emphasized the positive atmosphere and the constructive and effective cooperation. He informed those present of a Working Judge seminar that will be held from July 11-13, 2008..

# c.) FCI

President Henke reported on the good cooperation with the FCI, in particular as concerns the situations in Turkey, Brazil, Switzerland, and Ukraine.

# 2.1 Report by the Audit Committee

Herr Schallegruber reported on the audit of the WUSV finncial records that he and Herr Rudin had conducted. He reported that at the moment no clubs are in arrears with their dues.

Total WUSV expenses were about 45,000 Euros with a deficit being covered by the SV.

# 2.2 Ratification of the activities of the WUSV Board

Herr Schallegruber requested ratification of the actions of the Board of Directors of the WUSV during the past year, and this was approved unanimously.

# 2.3 Election of the Audit Committee

Herr Schallegruber and Herr Rudin were approved by acclamation to serve on the Audit Committee for the coming year.

## 2.4 Election of the Accountants

The firm of Geißlmair & Partner was also approved unanimously to serve as accountants for the WUSV.

# 2.5 Status of dues/deposits/initiation fees

President Henke reported an improvement in the dedication to payment by the individual WUSV member clubs. This was achieved largely by the withholding of judge's releases. In addition, the cost of hospitality for the WUSV General Assembly could be reduced.

He also referred to attempts by some clubs to avoid paying for judge's releases by requesting them through their Kennel Club. As a consequence, even the relevant Kennel Club did not receive judge's releases, since this is not the correct path to follow

The General Secretary clarified that the rating of "VA-Auslese" will only be recognized in Germany if a Protection test is passed, as in Germany. Each individual club, however, retains the right to award the rating "VA-Auslese". Such ratings will be recorded in the pedigree as "VA-Auslese (name of the country)"

## 3) New financial structure

a.) Increase in member dues by 50%

Change Section 10 in the WUSV Bylaws: Financing and dues payments

b.) Increase the fee for a "judge's release" by 50% from 100 Euro to 150 Euro

## 4) Information about Guest-, Junior-, and Full-membership

## 4.1. Acceptance as junior members

## 4.1.1. Kenya

The representatives from the East Africa German Shepherd Dog League were introduced by President Henke. This club has the possibility of acceptance as a Junior member of the WUSV.

If Junior member clubs need an SV-judge, they need to submit a judge's release request in a timely manner to the WUSV Board via the SV-Office. The club will then be assigned a suitable judge.

The WUSV Assembly voted unanimously to accept the club from Kenya as a Junior member.

#### 4.1.2 Egypt

The WUSV Assembly voted unanimously to accept the club from Egypt as a Junior member.

#### 4.1.3 Jersey

The WUSV Assembly voted unanimously to accept the club from Jersey as a Junior member.

## 5.) Introducing a WUSV-CACIB title; fee 0.40 Euro per dog exhibited (as of 2008)

This item will be postponed until next year's meeting.

# 6) Expulsion of the MNJK from the WUSV (from the 2006 meeting)

Since the situation is still awaiting a judge's decision, this item will be delayed until next year. Herr Szegvari, the President of the Hungarian Club, has promised to reimburse the WUSV for all legal costs that were associated with the previous legal actions.

## 7) Problem countries: Status

President Henke reported about several countries in which prolems still need to be resolved. This is the case particularly for Ukraine, Turkey, and Brazil.

## 8) Decision regarding the Rescue Dog (Rettungshund) program

This item will be postponed until the next WUSV General Assembly because the delegates have not yet received the source material.

## 9) Information about the meeting of the scientific commission

On the occasion of the SV Show judges meeting in December, 2007 the SV-Board met with Prof. Distil who is a member of the Scientific Commission. A report will appear in the SV-magazine and the WUSV Aktuell.

The General Secretary, Herr Lux, reported on a study by a member of the Scientific Commission, Frau Dr. Dorit Feddersen-Petersen, which attempted to measure the intelligence of dogs.

In addition, President Henke reported on the project in which drops of blood may be taken when a dog is microchipped so that the identity of the dog may be determined at any time in the future.

## 11) Retrospective on the 19th WUSV-World Championship 2006 in Randers, Denmark

The SV-National Training Director, Herr Günther Diegel, presented a brief overview of the WUSV-World Championship 2006 in Randers. He reported on the enormous working ability demonstrated by the dogs in the event. The high rate of failure in Phase A resulted from the strong winds in Denmark during the event. On behalf of everyone, he thanked the organizers for their outstanding work, as well as the judges, for producing an outstanding event.
