# ITEM 2) Annual Reports of the President of the WUSV and the WUSV Managing Director

### a) WUSV

The President of the WUSV, Herr Wolfgang Henke, reported on the three meetings in which the constitutional changes that are to be ratified today, had been worked out.. He informed those present, of the success In China, Costa Rica, Italy, Japan, USA, Pakistan, Korea and England. The Clubs are operating well with the Kennel Clubs.

The Brazilian Clubs have undertaken to amalgamate both clubs within four weeks.

The Representative of the Korean Kennel Federation expressed his thanks for the engagement of the WUSV in South Korea and for the wise decision. Next year, a meeting of those responsible for breed matters within all the WUSV Clubs is planned.

#### b) SV

The problems found in the motherland of the breed at the beginning of the term of office of the President, have been resolved. The SV Executive has decided at their meeting in July, to accept nominate again, in total, at the new elections to be held at the December General Meeting of the SV.

#### c) FCI

The way has been paved for efficient working together. The WUSV and the American Kennel Club have established a basis to exclude unwanted persons.

#### 2.1 Accountants' Report

Herr Schallegruber reported on the audit conducted with Herr Rudin , on the Balance Sheets of the WUSV and declared that the result of the 17.759,55 Euro deficit is to be attributed mainly to the costs incurred through the legal proceeding concerning the MEOE .

#### 2.2 Ratification of the WUSV-Executive

Herr Schallegruber proposed the ratification of the Executive of the WUSV. The members present voted unanimously for the ratification of the Executive.

#### 2.3 Election of Accountants

Herr Schallegruber und Herr Rudin were again proposed as WUSV Accountants. Both gentlemen indicated their acceptance should they be elected.

The members present unanimously elect Herren Schallegruber und Rudin by acclamation as accountants of the WUSV.

#### 2.4 Election of the Auditor

The company Geißlmair & Partner was again proposed as Auditor. The members present unanimously elected the company Geißlmair & Partner As auditors of the WUSV.

# 2.5 Payments of subscriptions/ bonds/acceptance fees – Report

The President, Herr Henke, informed the members present on the introduction of the approbation fee for WUSV Membership applicants

Meanwhile the Representative of Costa Rica has arrived. Therewith the voting count has risen to 53.

On this topic, Herr Henke thanked Herr Aspengren, who is not standing for re-election, for his services over the last few years. In recognition of thanks, he presented a sculpture of a German Shepherd Dog. Herr Aspengren thanked those present, for the great trust they had placed in him over these eight years.

Herr Henke proposed the ladies and gentlemen present, of the WUSV Office, as the election committee. All present declared themselves in Herr Henke explained the voting process in great detail.

As there are two persons standing for the election, it is a secret ballot.

- (4) Upon request of the Members' Meeting with a 2/3rd majority of valid votes cast, the exclusion of a member can be resolved in case of considerable breaches of the Constitution or regulations of the WUSV. Corresponding moves can be effected by the Managing Board, or the the member associations. The requests have to be substantiated.
- (5) Members can be struck\_off the membership roll, in case settlements of the contribution or other claims of the Association in accordance with section 10, subsection 5 and 6, are refused.

For the awarding of the grading VA, Excellent Select, in respect to the Protection Work, the SchH 1 is not the prerequisite, as mistakenly assumed in some countries, but the prerequisite is to complete the Protection Work, that in its demands, is commensurate with the Breed Survey Protection Work of the Motherland.

The WUSV Director, Herr Lux, explained once again, the resolution made in Ulm, in 2005 for clarification. The countries are self sufficient in their awarding of the VA-grading.
