48 voting member associations with a total of 230 votes as well as 4 Managing Board members with one vote each results in a total 234 out of 292 possible votes; therefore a quorum is given.

4.2. GHKL female dogs: Hans-Peter Rieker

The Judge of the working dog class for female dogs, Mr Hans-Peter Rieker, introduces the female dogs of his class which have received the ratings "V-Auslese" and "Vorzüglich"

4.1. GHKL male dogs: Reinhardt Meyer

The Judge of the working dog class for male dogs, Mr Reinhardt Meyer, introduces the female dogs of his class which have received the ratings *"V-Auslese"* and *"Vorzüglich"*.

TOP 2) Annual reports of the WUSV President and WUSV Secretary General

- a) WUSV
- b) SV
- c) FCI

The President, Mr Henke, refers at this point to the WUSV magazine, "WUSV aktuell", which can be picked up at the entrance after the meeting.

He reports about the new elections in the SV and introduces the new individuals entering the SV Managing Board to those present.

The examination regulations, valid starting 1 January 2012, were accepted by the SV, but shall now be referred to as "WUSV examination regulations".

He also hails the integration of the Long Stock Coat dog in the SV and the outstanding presentation in this year's SV German National Conformation Show.

He expresses sincere thanks to the SV head office and the "Bavaria North" regional chapter for the organisation of the event this year. Next year's SV German National Conformation Show will be held in Ulm from 31 August – 2 September 2012.

He points out that recording the meeting is not allowed. The President also requests to refrain from publishing minutes of meetings in the Internet, etc.

The President informs those present that despite intensive efforts, no agreement on the problems with FCI associations in some countries could be reached. The contract concluded with the WUSV was cancelled by the FCI. The notice of cancellation as well as an FCI circular is read out by the interpreters and is also attached to the minutes of the meeting as Enclosure 1.

However, the President assures that a good collaboration with the FCI is still aspired to.

The WUSV Secretary General refrains from providing a separate annual report. He addresses the time-consuming negotiations and matter with the FCI in detail.

TOP 3) Finances

At this point the President points out to those present that member associations which have not paid their 2010 membership fee are once again requested by the WUSV General Secretariat to pay the amount plus a reminder fee within the next four weeks. Otherwise judges will no longer be dispatched to these countries and the deletion from the member list is imminent.

3.1. Auditor's report

3.2. Audit report 2010

As auditor, Mr Schallegruber delivers a brief report on the 2010 WUSV financial year.

3.3. Exoneration of WUSV Managing Board

Mr Schallegruber proposes a vote for the exoneration of the WUSV Managing Board.

<u>Vote by acclamation:</u> The body is unanimous for the exoneration of the WUSV Managing Board.

3.4. Election of auditors and alternate auditor

Mr Josef Schallegruber and Mr René Rudin are again proposed as auditors. Both men would accept the duty in the event of election.

Mr Francis Reuther is proposed as alternate auditor. Mr Reuther would accept the duty in the event of election.

Those present unanimously elect per acclamation Messrs Schallegruber and Rudin as auditors and Mr Reuther as alternate auditor of the WUSV.

It is also proposed to elect the auditors for a longer period of time. An amendment to the constitution with appropriate content will be prepared by the WUSV General Secretariat for 2012.

3.5. Election of accountant

The accounting firm Susanne Huber-Kurtoglu in Augsburg is proposed as accountant by the WUSV General Secretariat.

Those present unanimously elect per acclamation the firm Susanne Huber-Kurtoglu as WUSV accounting firm.

3.6. Current situation with regard to payment of contributions/deposit/admission fee

The Secretary General explains that much fewer numbers of members are reported since the amendment to the constitution and the subsequently altered contribution rate. He asks those present to report their actual numbers of members, since otherwise an increase in basic contributions must be anticipated next year.

3.7. 2011 business plan

Those present unanimously approve by acclamation the business plan for 2011.

TOP 5) Amendments to the WUSV constitution Managing Board

5.1. Amendment in "§ 3 Object and Function": delete paragraphs (2) and (3)

Old version:

§ 3

Object and Function

- (1) The object and function of the WUSV is the worldwide implementation of the object and function of the WUSV in terms of the uniform breeding and training of German Shepherd dogs.
- (2) The Association is a non-profit organisation; it shall not pursue its own commercial interests as a first priority.
- (3) The WUSV's funds may only be used for the purpose provided for by its constitution.

New version:

§ 3

Object and Function

- (1) The object and function of the WUSV is the worldwide implementation of the object and function of the WUSV in terms of the uniform breeding and training of German Shepherd dogs.
- (2) The Association is a non-profit organisation; it shall not pursue its own commercial interests as a first priority.
- (3) The WUSV's funds may only be used for the purpose provided for by its constitution.

5.2. Amendment in "§ 5": insertion of a new section

Old version:

§ 5 Vacant

New version:

§ 5 Non-profit Status Preliminary remark

The fiscal model constitution for the non-profit status predetermined by the financial administration must be adopted verbatim in the constitution. The term "corporate body" utilised in the model constitution must be adopted with the proviso that the WUSV is meant.

 The WUSV with domicile in Augsburg exclusively and directly pursues non-profit purposes as defined by the section "Tax-Privileged Purposes" of the German Fiscal Code (AO).

The purpose of the corporate body is the promotion of animal breeding and dog sports as well as animal protection. The purpose of the constitution is particularly achieved through the measures mentioned in § 3 and 12 of the constitution.

- (2) The corporate body is a non-profit organisation; it shall not pursue its own commercial interests as a first priority.
- (3) The corporate body's funds may only be used for the purposes provided for by its constitution. Members do not receive any benefits from the corporate body's funds.
- (4) No individual may be favoured through expenditures which are alien to the purpose of the corporate body or through disproportionately high remunerations.

5.3. Amendment in "§ 30", paragraph (5):

Old version:

§ 30

Winding-up of the Association

(5) In case there is a winding-up of the Association or in case its actual object is eliminated, the assets of the Association will be given to the Federal Republic of Germany, which will use them subject to the tax-privileged purposes of said Constitution.

New version:

(5) Upon dissolution or abolishment of the corporate body or upon discontinuation of tax-privileged purposes, the assets of the corporate body will be given to the Federal Republic of Germany, which has to utilise them directly and exclusively for charitable, benevolent or ecclesiastical purposes which serve animal protection, animal breeding and dog sports.

<u>Vote by acclamation:</u> The body is unanimously for the motions pursuant to Agenda Item (TOP) 5.

TOP 6) Introduction of Stephanitz Medal

The President introduces the new Stephanitz Medal to the body.

TOP 8) Applications for membership in the WUSV, possible godfathered memberships

8.1. German Shepherd Club of Moldavia, Moldavia

The president of this association, Mr Ciuperca, briefly introduces his association and asks for a vote. The WUSV Managing Board recommends admission to the WUSV.

Vote:

The body is unanimously in favour of admitting the German Shepherd Club of Moldavia to the WUSV as a godfathered member.

8.2. Macedonian German Shepherd Dog Club, Macedonia

Vote:

The body is unanimously in favour of admitting the Macedonian German Shepherd Dog Club to the WUSV as a godfathered member.

8.3. Vietnamese Association for German Shepherd Dogs (VSV), Vietnam

Messrs Nguyen and Trung briefly introduce their association and ask for a vote. The WUSV Managing Board recommends admission to the WUSV.

Vote:

The body is unanimously in favour of admitting the Vietnamese Association for German Shepherd Dogs (VSV) to the WUSV as a godfathered member.

TOP 9) Progress reports of individual countries

9.1. Hungary

The President, Mr Henke, informs that legal clarifications are still pending between the two associations, but which would have to be clarified in the shortest time and can be reported about on the occasion of the WUSV General Meeting in 2012.

9.2. Russia

Dr Tauber reports briefly on how the deletion of the Russian Association for Owners of German Shepherd Dogs (RSVNO) came about. The association was legally dissolved in Russia and newly established under the same name briefly thereafter, but without legal succession, so that the newly established association was at no point in time a member of the WUSV.

In the meantime, a second association – RSLNO, which is also a member in the Russian Kennel Club – has been established.

Pursuant to the constitution of the WUSV, only one association in one country is admissible to the WUSV, so that negotiations were held and both associations have pledged to submit a joint application for admission to the WUSV. Unfortunately, the written agreement has not been observed to this day, and so Russia is not currently represented in the WUSV. The information will also be published on the WUSV homepage within the next few days.

9.3. New Zealand: Wellington District German Shepherd Dog Club

Since the association has not paid the contributions of the past three years despite repeated reminders, the Secretary General suggests expelling the association from the WUSV if they do not pay these contributions within the next four weeks.

TOP 10) Information regarding kennel name protection

Mr Lux informs that the WUSV's kennel name protection can possibly start as early as November of this year due to the cancellation of the contract with the FCI.

The association will then be informed per e-mail and via the WUSV homepage.

TOP 11) WUSV Universal Sieger Competition

Dr Tauber reports on the outstanding progress of the 1st WUSV Universal Sieger Competition in Hartkirchen (Austria). Several countries still had problems with the qualification mode, but would have to work this out within the next few years.

The next WUSV Universal Sieger Competition will be held in June 2012 in Slovenia. Belgium has been designed as the venue for 2013.

The associations from Italy and Slovakia have also applied.

The President, Mr Henke, expresses thanks to the applicants for assuming the organisation of the event and welcomes the keen interest in this universal competition.

TOP 12) Minimum requirements for breeding

The Secretary General, Mr Lux, refers to his article in the SV-Zeitung newspaper and in the WUSV magazine "WUSV aktuell", which is published in three languages there. The article may be published in the bodies of the associations, stating the source.

He explains the necessity of minimum requirements which are necessary for the breed in order to advance the breed of the German Shepherd Dog.

TOP 13) WUSV examination regulations

The body is unanimously in favour of adopting the FCI examination regulations valid starting 1 January 2012 as "WUSV examination regulations" under this name.

TOP 14) WUSV regulations for judges

Dr Tauber and Mr Henke explain to those present the necessity of introducing WUSV regulations for judges and the more specific planned course. Dr Tauber explains to those present the small changes of the hand-out compared to the version sent with the agenda.

Vote:

The body is unanimously in favour of adopting the hand-out version of the WUSV regulations for judges.

TOP 15) WUSV World Championship functional specifications

Based on experiences with the organisation of WUSV World Championships, the necessity of an introduction of functional specifications for the organisation of this event has arisen. This shall be a very comprehensive set of regulations which is attached to the minutes as Enclosure 2. The individual associations can also comment on this up to four weeks after the date of shipment, otherwise the functional specifications are regarded as adopted.

TOP 16) Review of the 23rd WUSV World Championship 2010 in Seville (Spain)

Dr Tauber reports on the very positive and outstanding course of the WUSV World Championship in Seville.

The WUSV Managing Board and the WUSV Secretary General express thanks for the fantastic organisation of the event.

TOP 17) 24th WUSV World Championship 2011 in Kiev (Ukraine) from 6-9 October 2011

The representatives of the Ukrainian association briefly inform those present about the preparations for the 2011 WUSV World Championship in Kiev and sincerely welcome all those present to Kiev.

At this point it is stated that the former Russian WUSV association is still allowed to participate in the 2011 World championship since membership was given at the time of notification and the notification was acknowledged. This will also be published on the WUSV homepage.

TOP 18) WUSV World Championships

18.1. Qualification with two member associations in one country

18.2. Admission criteria

Dr Tauber refers to the resolution adopted last year which absolutely must be maintained, since the quality in the lower segment of the event left much to be desired.

18.3. Agility

At this point the reference is made that the introduction of a separate event, the "WUSV Agility Championship", is planned and the starting signal will be given in Germany.
