#### Over the past year, here is a brief snapshot of what we have achieved:

Introduced monthly executive reports so that the membership is well informed on the activities of the Council - these are circulated to club secretaries for distribution of their



membership and posted on the GSDCA website for members whose clubs do not keep them abreast of activities.

- Held an open forum for members with the Continental Director to answer questions about the WUSV and Harmonisation at the 2023 National Show and Trial.
- Met with Vice President of the SV, Daniele Strazzeri, to brief him on the activities of the GSDCA and its member clubs, provide background and history and an in-depth look at our Breed improvement schemes. This provided an excellent segway for meetings with the newly elected SV executive at the 2023 Sieger Show.
- Delivered workshops and presentations for judges and surveyors.
- Held ZAP demonstrations across Australia, trained further ZAP coordinators for clubs that do not have resident surveyors.
- Developed the protocols for ZAP assessments and fine-tuned the applications processes.
- Met with WUSV Board members and countries under Heather McDonald's Continental Directorship at the 2023 Sieger Show
- Repaired the damaged relationships with the Council and WUSV/SV and achieved a positive platform moving forward.
- Provided the WUSV with a 30-page document on the activities of the GSDCA and member clubs over its history.
- Developed, updated, and distributed the GSDCA gradings guidelines.

#### **WUSV**

This year we witnessed a new President and board. I am looking forward to the future with the WUSV as I do believe the new administration understand the issues that many countries are dealing with, and this will lead to a more sustainable future. We will keep the clubs up to date with as things happen.

#### **Executive Members**

# **Treasurer's Report - Peter Flynn**

#### 2022/2023 Financial Year

This is my fourth report as Treasurer. I would like to thank the member club office holders for your assistance and prompt payment of invoices. Also, thanks to my fellow executive holders for their support.

I can report that the GSDCA made an Operating Loss for the year of \$(6,895) compared to an Operating Surplus of \$26,016 last year. A deterioration of \$33,011. The main reasons for the deterioration are:

The cost of producing the QNR increased by \$2388 although the number of magazines produced dropped by 1930 for the year. Which was mainly due to increased printing costs due to increased number of pages plus increased charges from the supplier. There was also a drop in the number of member subscriptions revenue of \$11,932, plus a drop in advertising revenue by \$2,255. For your information below are the member club subscriptions for this financial year and last year.

The NBC/Judges Meeting was held face to face in Adelaide this year which resulted in travel, accommodation, and meal expenses for the Council Executive members, compared to last year where the meeting was held via Zoom. The increase in affiliation fees was an increase in WUSV fees with an increase in our member declaration. The new equipment purchase included a new laptop for the secretary \$1288, HD&ED printer repair \$521, and upgrade of the NBC Registrars' laptop of \$227. The increase in the Trophies cost is due to the council paying for the Sam Bonifacio Breeders Trophy and LSC Breeders Trophy for 2019 and 2023 National Shows held in Melbourne (Note: the GSDL did not invoice the council for these trophies for the 2022 National). The GST correction is a historical adjustment that goes back to 2018 and was made in consultation and agreement with the auditor.

As at September 30, 2023 the council's cash balances totalled \$153,075 which is an increase of \$38,848 compared to the \$114,227 back in September 30, 2022. The main reasons for the improvement are:

•	Increase in Payables	\$25,899
•	Decrease in Receivables	\$12,268
•	Decrease in Inventories	\$ 7,666
•	Operating Loss	\$(6,985)



The increase in Payables was mainly the amount owing to Maroondah Printing for the QNR printing and distribution that was invoiced in August 2023, and paid for after the year end in October 2023. The decrease in Receivables was that on September 30, 2022, the QNR invoices to the clubs were outstanding and paid in October 2022. The decrease in

Inventories was due to the council ordering 1000 Standard Conformation Medals at a cost of \$8,425 (excluding GST) in 2022 reduced by sales in 2023.

- Canteen sadly our canteen had been non-existent for about a decade, so we were very excited to be able to provide this service to our members again, and pass on a percentage of any profit made, as a donation to our GSDL Welfare.
- Survey generated and delivered to involve members and seek feedback to guide decision making and include all members in the running of our club and inform regarding future events
- ZAP Tests initiated and up & running

- Continued Term deposits. Profitable options researched, explored, and initiated to safeguard our members funds and earn decent interest and income for the club.
- Re-structure and development of the GSDL Puppy Booklet

#### **Breed Surveys**

We held a total of 6 surveys throughout 2023 and the League has surpassed its numbers for 2022 and continued the upward trend of more animals being classified into the Breed Survey system. This is a pleasing result for the club to see members continuing to support the Breed Survey scheme.

The GSDL held a ZAP assessment in February this year. The GSDCA Obedience Chair, Alastair Henderson attended to guide us in the GSDL's first official assessment. Nine animals participated and were deemed competent in this assessment. A second ZAP assessment is scheduled for November.

#### **Trials**

This year we brought Obedience & Rally-O Trials back to the GSDL Calendar. In October we opened the trials to the Working Dog Group, and this was extremely successful for the club. We had 51 entries for both Trials and the entire process was very well received. It was lovely to be able to have the presentations in the Clubhouse, and to have fabulous trophies and ribbons available for the exhibitors.

We would hope that trials will continue in the future as well as continue to be open to the working dog group through the contracting of quality Obedience and Rally Judges.



#### **HDED**

This year we implemented an online application process for the HD & Elbow contracts via the GSDL website, which was met with great enthusiasm from our members. This process allowed a faster process for our members to obtain their contracts.

#### **GSDL Socials**

During the year we ran two social walks along the Nepean River in Penrith. # **National Breed Commission Report - Ian Urie**

I wish to thank again the Registrars and Officers who form part of and contribute to the Breed Commission throughout the year. I will make special mention of our HD/ED Registrar Doug West, who has held this position since 1984. Thank you, Doug, for virtually half a lifetime of dedication to this portfolio, and for the work you did in helping to establish the database that we all now take for granted. Thank you as well to our ever-reliable NBC Registrar Melanie Groth, for managing the collation and publication of Breed Surveys from all States. Thanks, must also go to Breed Health and Welfare Committee Chair Dr Candice Baker, Title Verification Officer Jenny De Lucia, and National Database Coordinator Frank Moody.

There has been a lot of work done this year within my portfolio, especially by the Working Party who were tasked with establishing a digital platform for our Hip and Elbow scheme. The invaluable I.T. knowledge and skills of our Website Officer Jacinta Poole has resulted in the creation of a process for online application and payment for HD/ED forms, and a digital portal for submission of x-rays to our radiologists and prompt receipt of results by email. This will bring our scheme into the 21<sup>st</sup> century and will hopefully substantially shorten the timeframe for receiving results, which has resulted from reliance on the postal system and submission of x-rays on physical media. The new system will be demonstrated at the AGM, and will hopefully come online for members shortly, following approval by the Clubs.

We were also asked last year to investigate the sourcing of statistics relating to GSD Hips and Elbows from the CHEDS/ORCHID database, and our database officer Frank has made inquiries via the ANKC Health Committee Chair Dr Karen Hedberg. We would need to apply for and pay a fee for each download from their database, but at this stage I do not believe the expense would be justified, because it appears that only one stud dog from within our own scheme has more than one or two progeny scored through the CHEDS scheme, and that dog is nearing the end of his stud career. We will continue to monitor the situation, including breed average scores, and advise if changes show up in future.

I also wish to thank on behalf of the membership Australia wide our Breed Survey teams in each State, comprising Surveyors, State Coordinators and Registrars, who officiate voluntarily at our Surveys throughout the year.

An historic event held this year was the WUSV Judges seminar held in Lerma, Spain. Our own Louis Donald and Dr Karen Hedberg were both invited to be speakers there, and Australia was also represented by Melanie Groth, Janet Haase and Vince Tantaro as attendees. Louis' lectures on the conformation and breed standard were apparently very well received. Janet and our Obedience Chair Alastair Henderson also represented GSDCA at the WUSV General Assembly held after the Sieger Show in Nuremburg.

I have enjoyed working with the NBC Executive - President Sean, Judges Chair Melanie, and Secretary Janet this year. We made the decision to hold the NBC, Breed Surveyors and Judges Committee meetings as face-to-face meetings in Adelaide this year, and I firmly believe that the camaraderie made possible with personal interaction is beneficial over and above the conduct of business by online forums. It was a successful weekend, and it was good to see all our Judges, Surveyors and Club representatives present, after several years where it was not possible due to



the travel restrictions of Covid 19. I also had the opportunity and honour to adjudicate with Melanie as Judges Chair on the Sires Progeny Groups at the 49<sup>th</sup> National in Melbourne.

Whilst it may be difficult for us to comply with all aspects, we are gradually working towards fulfilling some parts of the WUSV's Global Harmonisation ideals. The uptake of the GSDCA ZAP Character Assessment has been adopted by all States now, and some new Assessors have been trained and qualified. Our HD/ED and Health schemes have been recognised by WUSV. A comprehensive document detailing all that we do for the breed in Australia was prepared by Melanie and Janet and has been presented to the new SV Board at Nuremburg. We are also hoping to introduce a DNA scheme for proof of parentage, and with that in mind Dr Candy Baker has been negotiating with InfogeneNZ at Massey University in New Zealand, since the anticipated ANKC scheme did not eventuate. Candy has offered to conduct a pilot program in WA and will report on progress to the 2024 NBC meeting.

There was discussion at the NBC and Judges meetings in regard to making it easier for aspiring Judges and Breed Surveyors to enter the training/mentoring stages of the respective GSDCA courses. Several proposals were supported by the meeting and have been taken forward to the AGM agenda for consideration by the Member Clubs. These amendments will allow aspirants to commence their training prior to fulfilling all of the present prerequisites, however those will still need to be completed before the aspirants will become fully qualified as GSDCA Specialist Judges or Breed Surveyors.

The imported dogs whose titles have been verified by Jenny De Lucia are included in her report and listed on the Council website. It should be noted that imported semen to be officially recognised in our schemes needs to be verified by a similar process, and any imported dogs or semen advertised for stud in the Review must be verified.

# National Hip and Elbow Dysplasia Control Scheme Registrar's Annual Report

(primarily covering the period 1st Oct 2022 to 30 Sep 2023 to the AGM Feb 2024)

Once again, I'm pleased to present my report to the GSDCA AGM, this report primarily covers the 1<sup>st</sup> October 2022 to 30<sup>th</sup> September 2023, however the whole data base has been reported on to paint the whole picture of the scheme.

12,785 animals recorded in the Data Base as at 3/12/2023, comprising of 3,654 males (28.59%) and 9,131 bitches (81.41%).

As at 1st Dec 2023 there was 12,785 Hip & Elbow records in Councils Data Base, 3,654 Males (28.59%) and 9,131 (81.41%) females.

The 'A' stamp has been awarded to 11,154 animals, giving a pass rate 87.23% on Hips slightly up on last year's (86.6%). There was 12,361 successful in gaining the 'Z' giving a pass rate of (98.97%) for elbows, slightly up on last year's (96.65%), 10,509 were "Normal" (98.78%), UAP 147 = 99.99% Pass Rate.

For the period 1st Oct 2022 to 30<sup>th</sup> Sep 2023, <u>12 Month period</u>, 273 animals were presented to the scheme as depicted in Table 1A below. The pass rate on Hips for that period is: 96.72% with 265 gaining the 'A'. 270 animals successfully gained the 'Z' stamp, giving a pass rate for 'Z' of 98.54%, there were 0 animals with UAP over the 12 Month period, now that's a first, and a very encouraging result.

As detailed by the figures below in 1A, NSW has once again submitted the most over the 12 Month period with a total of 63 (23.36%).

<u>Table 1A</u> below covers the 1<sup>st</sup> October 2022 to 30<sup>th</sup> September 2023 "Individual Clubs Input."

There have been a total of 12,785 animal's results submitted to the GSDCA H&E Scheme during the Period to 3/12/2023. As can be seen there has been 11,358 gaining the 'A' stamp with a <u>pass rate of 88.84%</u>, and 12,360 animals gaining the 'Z' giving a <u>96.68% pass rate for elbows</u>.

Females had 47 = 17.22%, Males 12 = 17.2%. There were 0 animals with UAP.

Dr Lavelle processed 57 = 98.28% with Dr Richardson with 1 = 1.72%.

Dr Ana Hayes (PO Box 36, Vermont, Vic., 3133) has been added as the third Reader, and can now be nominated to score your X-Rays, stickers have been ordered to be placed on the H&E Forms advising Members of a third Reader and will be sent to the State Registrars once received from the



Printers. And Dr Mariano Makara has been appointed as our Adjudicator. Both are current Readers in the Cheds Scheme.

# **National Breed Survey Registrar Annual Report**

# Breed Survey numbers by State and Coat variety 1 January - December 2023

Thirty surveys were held between February and December 2023. A total of 151 animals were presented to survey this year, generating an income for the GSDCA of \$3915 for the 12-month period; 72 % Stock Coat and the remaining 28%, Long Stock Coats similar percentages to 2022. Dogs that could not be classified accounted for 9% of the total number of animals presented with 10 out of 14 (71%) failing the gun test; the remainder oversize (14%) or lacking self-assurance throughout the survey and or the character test (14%). One animal failed survey for the second time and therefore is disqualified from participating further in the Breed Survey scheme.



The table above and graphs below provide a visual representation and indication as to the health of the Breed Survey system in each state. year I suggested it would be interesting look to at these numbers with regards membership by state as it could an indication of where Breed Survey needs to be promoted further. It is worth noting that Victoria the state with the largest membership (almost half of the of the country has only managed to



encourage 22 animals to survey in the 2023 breed survey year, despite holding 6 surveys. On the other hand, Queensland and the GSDL have held steady numbers. There is movement across the borders of these two states as a significant number of enthusiasts that live in the northern NSW region find it easier to travel to Queensland who hold surveys in conjunction with shows. Tasmania has shown healthy growth of its Breed Survey numbers in recent years. The club holds surveys in conjunction with shows and relies on the Council to provide a second surveyor, whilst providing appointments to recently qualified GSDCA specialist judges. The GSDCT whilst only a small club support the schemes on several levels, holding surveys, ZAP demonstrations and assessments and education training events throughout 2023. It was encouraging to see the ACT club hold a survey this year again.



#### **Gun Test Fails**

Given that the vast majority of dogs failing Breed survey do so due to the gun test, it is a timely reminder of the importance of breeding with animals that are gun sure and are solid in character. Zap implementation may assist with this in future as animals that fail the gun test can not pass ZAP. Therefore, breeders and owners know prior to 18 months that their dog is gun shy and won't proceed to survey.

#### Database use

Most surveyors are inputting data into the database in a timely manner. Some need reminding! The NBC Registrar is responsible for inputting dogs that Fail and imported dogs. All others are the surveyor's responsibility. Once again, the biggest headache this year for me has been the lack of attention to **correct linebreeding**. Incorrect linebreeding then leads to questions with regards to breeding recommendations and then these have to be checked and re-checked. This takes time and energy and slows the processing of surveys down somewhat. We need to do better in this area. Some of it comes down to educating members about the accuracy and legibility of five generation pedigrees, however the onus is on the Surveyor to check and double check linebreeding and get it right.

I have highlighted these most common errors now for two to three years. Surveyors, please take note as errors still keep occurring:

- failing to check spelling and grammar
- incorrect linebreeding and incorrect spelling of the linebred dog's names
- cutting and pasting from the general description into the faults and virtues section this is repetitive and unnecessary
- not checking height to depth; incorrect labelling of size in general description and transferring that to the faults and virtues section
- failing to input the height, chest circumference, weight etc into the database when transferring from the BS worksheet.
- Capitalising dog's names and including von, vom, du, prefixes. Correct example Cayos Noriswand (no von) Vegas Haut Mansard, Quenn Loher Weg



#### **General Hints**

- DRAFT Button This is so you can save your work and come back to it if you need to. Once you have proofread your work, you can set the survey to Pending, which indicates you have finished with it.
- Type the general description into a word document -spell check it and check your grammar. There should be one space after a full stop. Some surveyors type their critiques as one sentence, this means a lot of commas. Read the survey description, virtues and faults etc back to yourself after you have typed it and make sure it makes sense. Remember, it is in print for life and they are your words. Once you are happy with it cut and paste it into the appropriate area in the database. If you use a secretary or third party to type your critiques make sure **you** read it before pressing pending.
- Linebreeding Read Jenny's article from 2020. Check the linebreeding before you open the database. Check the 6<sup>th</sup> generation. Some of the five generation pedigrees are not very clear. There are quite a few littermates coming through behind Djambo, Toby and Xaro. Quite a lot of Quenn and Furbo also coming through now. If you pick up anomalies, please inform NBC chair or myself so they can be rectified.

**Describing dogs Section 12 Breed Survey Manual** – use the tables provided regarding height and size. There are specific instructions around the General description p.15-17. You can always use the updated Grading guidelines – specific height descriptions and chest depth variations are located here. <u>GSDCA Grading guidelines 2023</u>

- Size use the BS table guide for size in the general description.
- Depth and Height use the equation to get a percentage to avoid saying a dog has very good proportions when it is 50:50 or more. An example recently male 62cm 32 chest depth was critiqued with very good proportions and followed up in the drop-down menu with the same.
- Recommending dogs for breeding some surveyors are recommending dogs recently imported without sighting them or recommending further linebreeding advantageous to dogs that are known to produce oversize.

#### **Allocating Club and Council numbers**

Registrars and surveyors please note - this is repeated from last year again! I am not sure why Breed surveyors are not getting this right. State Coordinators please meet with your registrars and survey team to ensure club numbers are correctly issued on the BS7 worksheet and BS11 Report

Breed Surveyors please take note that your club has its own unique numbering system. It is essential for identifying where the survey has taken place. Each state club has its own Breed Survey Register. Please use your state club's prefix for this on the BS7 worksheet and when typing in your survey and on the survey report. Council numbers are allocated once paperwork is received, they are distributed into Stock coats and Long Stock coats. If the club prefix is missed by the Registrar inevitably the surveyor misses it and it is then left to the NBC Registrar to pick up. It would be helpful if you could attend to this at the club level.

The BS11 form is a useful tool in allocating council numbers to survey and collating numbers for reports. If the BS11 form is sent to the NBC Registrar straight after the survey it allows time for the preparation of numbers for invoicing and processing to be printed. Some clubs still find this challenging. Please revisit the use of this form. Coordinators across all states need to ensure this form is used for every survey even if you are not present.

Thank you to the state registrars who do a great job in preparing the paperwork for surveys. Special thanks to Peter Hersant in Queensland who has done an amazing job in the registrar's position. Peter is often in contact and ensures Queensland surveys are well organised. Thank you to Frank who makes sure that the backend of the database is regularly checked and troubleshoots and builds pedigrees for me when data is missing.

# **Processing surveys**

There have been some issues this year with uploads to the database from DogsAustralia who fell behind earlier in the year. This meant that some of our imported animals were not in the database in a timely manner and I thank the owners for their patience in having to wait for their verified Australian surveys. More concerning however was the lag in the upload of HDED results to the database. On a number of occasions, I was unable to process surveys because the results were not in the database. Six months should be plenty of time if the animal is X-rayed at 12 months before going to survey at 18 months. Thank you to the owners of dogs who patiently waited for their surveys to be processed.

Owners often need reminding to provide suitable photographs of their dogs for upload to the database. It would be helpful if these were chased up by the club registrars. A GSDCA logo is uploaded when no photo has been provided.

# **Final remarks**

I would like to thank the registrars for their cooperation in managing the administrative side of the survey processing. I would ask the State Coordinators to be much more proactive in ensuring survey teams are ofay with the rules and regulations of survey and encourage the reading of reports such as this one, so that the surveyors are responsible for their own work and not reliant on the registrars to fix errors. We have a system and a process and when it is followed it runs smoothly. The NBC chair has asked me to keep him abreast of recurring issues in future. Please check your work.

# **Breed Health & Welfare Registrar Report**

Dr Candice Baker BSc BVMS MANZCVS (ECC)

This past year has been relatively busy behind the scenes and hopefully as the forthcoming NBC and AGM's roll around, we will see some changes.

The most interesting thing for the general membership has included some consultation, collaboration and teamwork in trying to modify and consider some changes to our schemes. This



has included working with our national hip and elbow working party with the much-needed inclusion of Jacinta Poole for her extensive digital knowledge. Advancing our scheme in the digital age is paramount, as the loss of members utilizing CHEDS over GSDCA simply comes down to accessibility and ease of use with their vet clinic.

It should be noted that we need to continue to keep an eye out for any comment on hip and elbow scoring sheets for lumbosacral transitional vertebrae. Consideration of assessment of the lumbosacral joint on our hip scoring radiographs is an ongoing area of interest to me. With the SV using the system of LUW and OCD - these abbreviations refer to lumbosacral transitional vertebrae and osteochondrosis of the sacrum. The Score of 0 or normal represents the lack of a transitional vertebrae finding or the lack of any osteochondrosis of the joint space.

In the past few months, I have spent some time liaising with Professor Clare Wade who is a canine geneticist from Sydney University and contacting and working with InfogeneNZ which is the Massey University based DNA laboratory. Due to the strong push from the SV to implement a DNA scheme for parentage being paramount. Given DogsQLD have moved towards using InfogeneNZ as their preferred laboratory. There has been some consideration and research into a club-based DNA by parentage scheme using this laboratory. Further information on this will be presented at the next NBC meeting.

There has been ongoing monitoring of health profile forms from the general population and correspondence with those with general feedback and thanks for their contribution.

# **Verifications Officer Report**

This report for Title Verifications covers the period November 2022 to December 2023.

During this time, a total of 9 animals have been verified compared to 6 animals for the 2021/2022 reporting period.

Of these, 8 x were Males and 1 x Female. 6 x were Stock Coat and 3 x Long Stock Coat. Three of the verifications were for imported Semen. Of the 9 animals verified, one was not Breed Surveyed.

Thanks also to the remaining members of the executive; Sean for his ability to calm things and pour oil on troubled waters, lan for the attention to detail and history lessons at almost every meeting, Alastair for raising the profile of Obedience and Performance sports, Peter for his ever-wise counsel, and Yvonne for always reminding us of our duty to the whole breed. Thanks to all for your continuing efforts throughout the year to conduct the business of the Council. We did not always agree but I am grateful for your support.

### **NSLO**

Thank you to Vince Tantaro the National Show Liaison Officer for his work in ensuring the 49<sup>th</sup> National Show Report was delivered on time. He also responded effectively to the working party request from the NBC meeting for examining the scheduling for future National Shows. A report from this group is currently being considered by the Executive and will be tabled at the 2024 AGM. Vince is an experienced operator in the Council and is always ready to respond, drawing on his corporate knowledge of the Council and longevity as Club and Council President. His role is to liaise with clubs to assist with advice and organisation of future Nationals. He has been frustrated this year at not being able to liaise directly with the SA Club running the 50<sup>th</sup> National as they preferred not to have his input.

I urge clubs to utilise the NSLO as a resource when they are planning and running Nationals as they can often troubleshoot issues that many clubs face prior to them becoming big problems. Vince will hand the portfolio over to Jess Lynch in 2024 and I wish her well in the position and thank Vince for his efforts in 2023.

# GSDCA Judges training scheme and accreditation

Andrew O'Loughlin was awarded his GSDCA Judges Certificate and Badge at the 49<sup>th</sup> National in April. Andrew is now a fully qualified GSDCA Specialist Judge and is also active in promoting the breed in the All-Breeds ring. Andrew provided quality feedback on the working document for the updated Judges Grading guidelines and his ideas and suggestion were accepted for inclusion.

Matthew Morris completed his ANKC examinations in October this year and has begun the second phase of the Extension course. Matthew judged in New Zealand in November, has an appointment in Auckland in February 2024, and will judge again in NSW in February for the GSDL. He has a busy time ahead.



Discussion regarding the GSDCA regulations and requirements to become GSDCA judges and Surveyors took place in Adelaide at the 2023 NBC/Judges meeting. Whilst it was generally felt that the regulations in place protect the integrity of the schemes; it is also acknowledged that requirements for entry into the training schemes were a demotivating factor to the younger generation of enthusiasts who may be interested in becoming judges or surveyors in the future. After much consideration, motions were formulated for the 2024 AGM that do not undermine the integrity of the regulations, but to the contrary, make the requirements achievable whilst a judge is in training. Acceptance of these motions enables the Council to support the progress of our trainees, simultaneously providing mentoring, guidance, and direction by our most capable senior judges.

Congratulations to judges; Jessica Kada, Glenn Gregory and Kurt Morton who were accepted to enter the Breed Survey Aspirant scheme. They have all commenced their training at our last Sydney survey and hopefully they will be successful in gaining their survey status after next year's NBC meeting.

# Judges contacts and appointments

Once again, this year, Jane Pike has continued to maintain the spreadsheet for the GSDCA judges/surveyors. Address details have been updated but are not published on the website. The <u>GSDCA Judges contact list 2023</u> can be found on the website via the shortened link provided. The appointment list <u>Judging appointments 2024</u> can also be found on the same page. Thank you, Jane, for providing this valuable support to the Judges Committee.

### WUSV/SV

In April, along with Lou and Gail Donald, Jan Haase, Karen Hedberg, Vince, and Fran Tantaro, I attended the GSD World Conference in Lerma. This was a valuable educational conference and made me very proud to know that Australia was well represented by Louis and Karen as presenters on the World GSD stage. Louis' delivery to the Judges Seminar was amazing and I was able to share some of this work with our judges at the August NBC/Judges meeting in a presentation. Louis' presentation on Long Stock Coats, assisted by Karen's work and presentation, was groundbreaking for the acceptance of arguments for inter-variety breeding and perhaps removing one of the barriers toward achieving Harmonisation.

Lerma also provided an opportunity to work with our Continental Director, Heather McDonald in how she can best assist us in meeting the expectations as a member of the WUSV. Heather addressed a hundred or so interested exhibitors at the Thursday meet and greet at the national and fielded questions from the floor. A report was compiled by Robyn Knuckey and I and distributed to member clubs after the National this year.

During the year I polled Judges regarding the proposal of a change to recognition of National and International judges and WUSV Judges Training. Feedback from our survey was sent to the WUSV and is included for the Working Party set up to review the proposal.



# GSDCA Gradings Guidelines update

The previous document was last amended in 2017 and as such required an update and provide alignment in accordance with GSDCA regulations. A cross-section of senior and more recent judges was selected to provide feedback. This led to a quality document that has now been distributed for Judges to use in their assignments. It has also been sent to Member Club secretaries for inclusion in the package sent to international judges when they are contracted and to be provided on their arrival prior to judging our shows so that they are familiar with our regulations. # <u>Critiques at shows - reminders for member clubs and</u> judges

Section 5 - Conduct of Specialist Shows and Restricted Trials. The Regulations Manual p33 outlines the necessary steps to

meet GSDCA requirements. A stenographer is to be made available for judges. Critiques are to be provided to the Judges Chair in electronic form as soon as practicable after the show. Technological skills vary from club to club; however, some general rules of thumb need to apply and I recommend judges take note of the points below.

Prior to sending critiques to the judge, clubs should ensure the following points are attended to:


- o Heading includes club, name, date and venue for the show and judge's name.
- o Separate the coat varieties with headings Long Stock Coat females/males, followed Stock Coat females/males.
- o Label each class.
- o Challenges/"Best ofs" recorded at the completion of the open classes for each variety
- o Critiques should include CH title if appropriate, name of dog \* for surveyed animals, A, Z, registration number, sire/dam, name of exhibitor
- o Critiques should be arranged in finishing order from 1<sup>st</sup> to the final placing. Absentees noted and listed after the final placing.
- o Gradings visible at the end of each critique.
- o Open class animals reaction to the gun test recorded on the critique in consultation with the judge.
- o Interclass and inter-variety opposites competition recorded at the end of the critiques.
- SBE's should include a Sires progeny report and detailed reasons why Excellent Merits were considered with details, placing of progeny, applicable data A, Z, progeny surveyed etc

Once this task is completed by the stenographer the critiques are to be forwarded electronically to judge for the final editing.

Judges prepare a brief overview of the show that could include the following:

- o thanking the club and ring assistants
- o show conditions

- o any points that you might consider worth mentioning about the virtues of the animals presented etc. This should be inserted underneath the heading of the show before the critiques.
- o Proofread the critiques making sure that critiques are aligned with eventual winners (a dog may do a particularly good individual and yet perform poorly during the balance of the class and end up going backwards, yet has a better critique than your winner always check this)
- o Upon completion return critiques to the club with your edits and cc to the Judges Chair <u>iudgescommittee@asdcouncilaustralia.ora</u>

Finally, as per Regulation 5.1.1.6 Finalized critiques are to be sent by the Club to the Judges Committee Chair, who will arrange for the critiques to be sent to the NBC executive and to the GSDCA Website Coordinator. I recommend a word copy and pdf be sent to the Judges' chair just in case any errors are picked up and can be amended before being posted on the Council website.





# Judges Seminar, World Congress, Show, Dog Sport, and a WUSV Special Assembly

There were three themes flowing through the WUSV GSD Congress and Judges seminar.

- **Ethics** in judging and breeding.
- **Health** of the dog, both physically and mentally.
- **Unity** connecting as a community to protect the wellbeing of the breed.

#### One Breed - One World

The week featured a multitude of events and competitions; an International Working Dog Competition, Agility workshop and competition, seminars with speakers from all over the world (21) and a seminar for judges in terms of breed and trial, seminars for veterinarians covering performance of official x-rays for the diagnosis of hip and elbow dysplasia.

The event was organised in collaboration with the WUSV Board and REAL CEPPA team led by its president Javier Silva Parrondo and event coordinator, Rodrigo Gonzalez Campuzano. A host of volunteers did their utmost to ensure the needs of all the presenters, exhibitors and attendees were met.

At the heart of this global forum was the desire for networking and community building, to jointly explore how to collaborate and contribute ideas, how to challenge thinking and the status quo.





# The Judges Seminar


The week began on Tuesday with the judges' seminar for both working and breed judges. The working judges' forum was led by a board member, Vadim Plotska. Presentations will be available for viewing in due course.


Margit van Dorssen, SV Judge, began the breed judges forum with a lecture on the role of the judge. Roberto Caputo explored the 'hypo' and 'hyper' types. An interesting poll was conducted during this section about which dog of the past most closely reflected the standard. The two dogs shared the top spot, Quenn vom Loher Weg and Remo vom Fichtenschlag.

Louis Donald followed with a presentation that examined judging in the standard today. Focus was on the objective versus the subjective elements of the standard. The meeting culminated with the WUSV/SV President Heinrich Messler exploring the responsibility of judges and future challenges. It was a long day, 8:30 am until 8:00 pm.



Gabrielle Labbe, from Guatemala, very capably translated the presentations. The main languages spoken were Spanish, English and German. This was a challenge for all and added considerable







time, nevertheless we had great interaction through Roberto Caputo's use of Mentimeter and Louis breakout group discussing elements of the anatomy and the challenge they present to judges.



## The Congress

# **Thursday**

A series of presentations covered the value of using DNA and Genetic technologies, the value, hazards, and pitfalls in pure dog breeding, examining inbreeding depression and the challenges for purebred dog. Ursula Zabel, a long-time lover of the breed and past Board member enlightened us with her provocative views on pure dog breeding in the Twenty First Century. Louis Donald presented excerpts from his recent book on the value of the breed standard today. Professor Messler continued the theme of pure dog breeding, the strain on welfare organisations, GSD inbreeding depression. Over typing leading to torture breeding where exaggerated animals are in pet homes and have the effect of damaging the reputation of the pure-bred registered dogs.




Professor Udo Garislosser provided an amazing online presentation. He examined the heredity of mental traits; a fascinating insight into epigenetics and the inheritance of characteristics - such as anxiety/fear resulting from stress (more mother related than father), aggression, and ADHD. He



concluded that tests to assess these characteristics should be intuitive rather than be trained for and cannot be covered with one assessment.

Dr Karen Hedberg enlightened us with information that impacts on pure bred dog breeding in closed populations. For example, the more characteristics you test for and eliminate from breeding programs further limits the availability of lines within a breeding population in a country. The limitations are manageable in a larger population but can have significant impact in smaller populations. This was a good segway into the controversial topic of inter-variety breeding later in the day.



Costa Rica's Dr Alerto Gamboa presented the Congress with some interesting points regarding the introduction of Artificial Insemination (A.I.). He offered contrasting information that impacted on the hard rules around the non-promotion of A.I. and canine welfare regarding the closed population of purebred dogs in countries. He highlighted issues around vast countries and the inability to travel dogs on planes limiting access to sires.

The SV's leading Radiologist Veterinarian, Dr Bernd Tellhelm spoke about advances in hip diagnostics, explaining the benefits of National and International hip schemes that will enable and enhance the collection of data for analysis.


The final session of the day was a combined presentation from Louis Donald and Karen Hedberg who were tasked by Prof. Messler to challenge the notion of inter-variety breeding.

Louis presented research of coat varieties from the formation of the GSD in Von Stephanitz' era. This was thought provoking and enlightening about the types of coats that were eliminated from the initial standard. It was established that at that time Von Stephanitz described three coat varieties; curly/rough coat, bearded shaggy and short coat. He discarded the curly/rough coat and bearded/shaggy coats leaving the breed with the stock coats of varying lengths. This was a light



bulb moment for many of us. The SV's interpretation of this action was to discard LSC, and this was written into the standard.

Karen's' presentation of a simplified version of the genetics of breeding SC and LSC along with a close look at the data from NZ, Australia, and Germany (+20 years) amplified the notion that the LSC population were currently stable at around 20% and had remained that way for close to 20 years. Thus, indicating in this example, that inter-variety breeding would not adversely affect the population of stock unless there was a shift in approach by breeders to select for LSCs and dismiss SC in their breeding programs.



It was unfortunate that the WUSV IGP Championship was held on this day as many of the presentations would have been of much interest to the Dogsport enthusiasts.

#### **Friday**

Friday morning many of the breed enthusiast went to the show to participate in or watch the individuals of the puppy classes. Presentations continued at the Parador Hotel for the dog sport enthusiasts. The afternoon session covered animal welfare, legislation, association trademarks and compliance.

### **Saturday**

TSB training for judges and helpers took place in the morning, followed by the TSB tests for working class males and females, and then the individuals for the male and female 12-18-month, 18- 24-month and the working classes.


The draw of the judges of the senior classes took place at the Parador at lunchtime.

The seminars continued, starting at 8:30 am with Prof Messler challenging the beliefs around deep hind quarter angulation. His presentation was aptly titled 'Over typification' of the Hindquarter. Utilizing Louis' work and images and that of Prof Fischer, he presented an excellent overview covering anatomy, examining the impact of over long bones in the hind quarter and the impact on



the lateral and cruciate ligaments of the knee joint during movement and walking. He also examined the effect of the curved back, lower hip position, long femur and tibia and challenged the notion of endurance versus sprinting. He spoke about the judges needing to control the ring and limit the normalisation of the sprinting GSD.

He concluded with a summary that highlighted how these faults reduce GSD endurance and economy of movement.



Rene Rudin provided a brief overview of harmonisation levels, DNA and HD/ED. Our continental director, Heather McDonald, asked him about countries that have their own established schemes and whether consideration could be given to alignment with the WUSV/SV system. This was going to be raised with DR Tellhelm after the veterinary presentations.

Mr Chen, President of China delivered a presentation about the development of the organisation in China and highlighted their achievements since their formation in 2001.

Javier Nectali Diaz, from Spain, demonstrated an app that had been developed that could enhance data collection and analysis.

# **Thoughts**

It was a full program of presentations over three 12-hour days. Thought provoking and enlightening.

The theme of ethics was evident throughout and the effects of ethics on every facet of the GSD community from breeding dogs, pet food companies, hiding faults, judge corruption, concerning trends of linebreeding depression, canine welfare and the importance of positive identification and its impact on canine health schemes and breeding programs.



Australia was well represented though its presenters Karen Hedberg and Louis Donald. Louis's material has been embraced by the WUSV and its president, Heinrich Messler. As a country and a GSD community we can be immensely proud of their contribution to the breed on a global scale. In all, seven Australians attended, paid their own way to contribute to this amazing week of learning, collaboration, and innovation. As a country we have much to celebrate, and we felt the warmth and camaraderie from other countries who share our challenges. We share many common issues across our community of political agendas regarding canine welfare, health and diseases, and legislation.

# **WUSV Special Assembly**

At the completion of the presentations the authors of this report represented the GSDCA as delegates for Australia at the WUSV Special Assembly.

This meeting was called to consider the working party's recommendations (formed in September 2022) for change to the bylaws and statutes to comply with new legislation. The changes outlined in the agenda 3.1 to 3.9 and 3.11to 3.15 were passed unanimously. These were recommended by the SV lawyer; chair of the working party, to reduce discrimination and modernise the statutes to align with current laws.

#### 3.10 The Board of Directors

The move to expand the Board of Directors involved some discussion, as the motion put, if passed increased the number and compilation of the board members from 4 to 6/7 (depending on the President of the SV or past president). The board members elected will be proposed by the member clubs of each zone.

The zones are:

- Europe and Africa
- South America
- North America, Central America, and the Caribbean
- Asia, Pacific and the Middle East

Australia would be able to propose a nominee to represent the Asia, Pacific and the Middle East zone. Voting would be conducted by delegates of the WUSV member clubs at the General Assembly.

Australia abstained on this item. Item was passed.

## **WUSV Judges**

The draft regulations were presented to the meeting. The revision of the regulations was required to remove any discriminatory factors that would not be allowable in many member countries. i.e., forced retirement at age 70. If passed these regulations would recognise judges training schemes



and qualifications in member countries and open access to applications from members to become National or International judges. The draft was well received by member clubs. Feedback is required from member clubs on the draft is required by 15<sup>th</sup> May to inform the final submission that will be presented to the next General Assembly in September.

# **Takeaways from the WUSV Week**

- The advantages in genealogy relating to health and character traits mean that DNA tools
  for identification and correct family may make it possible in the future to identify health and
  character issues.
- The presentation on LSC intervariety breeding has raised questions for the SV and WUSV to consider its current position.
- We must consider the character and working traits of our GSDs to preserve their inherent qualities as a herding, working, protective and social family pet. For this it means we need to implement a working assessment qualification that is proof the dog can use its brain if we wish an SV excellent in the near future (2025).
- Extremes in our breed are evident in both show dogs and working dogs. We must work towards balance.
- We met many qualified, enthusiastic breed judges that are not domiciled in Germany that speak English and could easily hold their own judging our events.
- There are many benefits for the GSDCA to remain as a WUSV member and rather than withdraw. The Congress proved that the WUSV can be an educator and binder of common goals to serve a diverse pool of GSD enthusiasts from around the world. The WUSV demonstrated it is an organisation that can serve the welfare and betterment of the GSD worldwide!

# **WUSV Meeting Report**

## **Meeting One - Friday 8 September 2023**

Alastair and I met with Heather McDonald (our Continental Director) along with the representatives from countries under her supervision. (Finland, Norway, Sweden, Great Britain, Ireland, and Australia.) Heather provided an overview of her discussions with the WUSV Board of Directors.

The Board was much more understanding of the difficulties countries have in meeting the Harmonisation requirements, much more willing to accept National schemes for HD/ED and DNA and no longer require protection work as part of a working title. The President and the board expressed a desire to listen and negotiate mutually acceptable outcomes. The breed's health, both mental and physical, being the prime objective.

#### Items discussed.

- 1. DNA for proof of parentage there is no expectation the test will need to go to Germany. In fact, it is illegal to send blood internationally. The SV will provide us with the markers allowing us to set up our own scheme, using an accredited lab in Australia or NZ. The suggestion being that samples are collected at the time of hip and elbow Xray; therefore, we only test those animals we want to show and breed. This scheme would be recognised within Australia and be a *National DNA* proof of parentage. (Note: It would be a positive move to begin investigation of this as soon as possible. Our Health Officer, Candy Wedge, has offered to begin preliminary research.)
- 2. HD/ED once again it is highly likely our own hip and elbow scheme will be recognised and valid for all purposes within Australia. Heather is meeting with Dr Tellheim to advance this further. They will be looking at our scoring system and alignment of the schemes.
- 3. A working title it was emphasised there is no requirement for protection work. We have a variety of options to meet the requirement for a working title.
  - a) We could look at utilising suitable Dogs Australia's recognised dog sport fields.
  - b) We could develop our own working test involving basic obedience, a track, and a jump for example.
  - c) Or it could be a combination of both above, with a range of activities recognised for the purposes of a working title. We need to consider access to trainers and assessors.

These schemes would be used by Australian bred dogs for Breed Survey and Excellent gradings within Australia. Those wishing to compete outside Australia would be required to use the SV schemes.

Norway's three-tiered Breed Survey system was outlined.



- 1. An SV style breed survey with protection work that qualifies the dog eligible for a VA/V grading.
- 2. A breed survey that requires an obedience/tracking qualification. They have developed their own program that does not require bite work. This Breed Survey qualifies the dog eligible for a V grading.
- 3. A breed survey with no working qualification requirement. This allows the animal to be bred from.

In summary we use our own HD/ED scheme, develop our own DNA scheme, continue with the ZAP Assessment, making it a prerequisite for Breed Survey and develop a range of avenues for gaining a working title.

At the end of the meeting Roswitha Dannenberg and Daniele Strazzeri joined us to introduce themselves, express their understanding of the difficulties countries have in reaching compliance with the harmonisation schedules. They assured us that the new board would listen, be problems solvers and improve communications. They willingly answered questions and were open to compromise.

Regular three-monthly Zoom meetings will be held with Heather, representatives from the countries for which she is responsible and Roswitha Dannenberg.

Daniele offered to meet Australian club and council officials in attendance at the show the following day to open communication.

## **Meeting 2 - Saturday 9 September**

Meeting with council officers, our Continental Director, Heather McDonald and the Vice President of the SV. Daniele Strazzeri.

Those in attendance were:

- Daniele Strazzeri, Heather McDonald
- Janet Haase and Alastair Henderson
- John De Lucia (SA), Jess Kada (NSW), Gabrielle Peacock (TAS) club representatives.
- Candy Wedge (Health Officer), Vince Tantaro (NSLO and past President).
- Chelsea Bird (Youth Officer) was invited but declined as the class she was most interested in watching was being run off.

Heather recapped the items discussed at the previous day's meeting (See notes above). Those present were able to offer views and ask clarifying questions. It was suggested that the timeline for compliance would be extended to 2027; the timeline will be discussed at the WUSV meeting. (\*Please note outcome from WUSV meeting)

Suggestions offered by the group for a working title included those offered by Dogs Australia. (Since the meeting, a summary of the elements of the dog sports offered by Dogs Australia has been sent to Heather to aid in discussions.) It was suggested that one pass in CCD could meet the requirement of a working title. Or it could be ET, tracking, scent work, agility etc. Alastair and John's



input in this area was most valuable. Daniele was supportive of us using acceptable dog sport qualifications.

The DNA proposal for a National was discussed with positivity. It was felt important that a proper, detailed, and costed proposal be put to the council. Candy Wedge was prepared to work on this with support from the NBC Executive.

Candy was able to supply more information about our hip and elbow scheme, which was particularly useful. Information is noted on the result form if lumbosacral transitional vertebrae is evident.

Daniele reiterated that the new board of the SV and the WUSV wanted to collaborate with member countries and negotiate suitable harmonisation outcomes.

Heather is to be commended for the work she has done in supporting and negotiating on our behalf. I suggest we write to her expressing our gratitude and thanks.

#### **Meeting 3 - WUSV General Annual Assembly**

Monday 11 September 2023



The agenda was approved with a rearrangement to the order of items. Item 7 being moved to follow item 4. This was done to accommodate those who may need to leave early.

This report is designed to give highlights of the meeting and is not a complete record of the meeting. The minutes of the meeting will supply the detailed account.

The President, Roswitha Dannenberg, introduced herself and set the tone of the meeting by stating that there was a need to reestablish trust and harmony between the WUSV and the SV. She acknowledged there was significant conflict between the two organisations. Her goal is to stabilise the organisations and work collaboratively with members. She identified communication as an area in need of significant improvement. She said the board was aware of members' concerns and will look at engaging in meaningful dialogue to resolve these disagreements. She said the board was enthusiastic about the members' activities.



Frau Dannenberg was aware that people were trying to promote conflict and that a joint way forward needed to be found. She guaranteed there would be improved cooperation and communication, that she was solution oriented and would direct her focus to resolving issues and obstructions.

She was heartened by the attendance at the meeting and wanted to thank all for their congratulations on her election as President. Frau Dannenberg's address was very well received by the meeting, and she was given a standing ovation.

- The Auditor's report was received and the budget plan for the coming year approved.
- Kuwait was accepted as a full member after much discussion although it did not meet the regulations requiring two hundred members. The statues to be amended.
- Lebanon was also accepted as a full member, meeting all the requirements.
- Nigeria was admitted as a Junior Member.

There was active discussion on issues regarding the **Harmonisation Breeding Program** (HBR), accessibility of services, and capability of member organisations to comply with HBR regulations. The meeting acknowledged there needs to be greater equality for member organisations. The HBP is about the health and wellbeing of the breed universally, and members need to be able to access and use local accredited services to meet the requirements.

#### **Outcome**


A working group will be established to consider and review the HBP. There will be a fixed timeline, with a small group representing the continents, working quickly to provide a report to the Board. The working party is to be set up and led by Rodrigo Gonzalez Campuzano.


















The next item discussed was the impeachment of the President and/or any member of the Board of Directors of the WUSV.




The motion was about the president's loyalty to the WUSV. Is there a conflict of interest given the SV president is automatically the President of the WUSV? This was brought to a head by the SV veto of the Lerma motions. Did the vetoing of the Lerma proposals indicate that the WUSV was not important to the SV and the WUSV was viewed as subordinate to the SV? There were additional issues raised that occurred in 2019.

The motion to impeach was lost on the understanding that the new president will endeavour to reestablish trust and stabilise the relationship between the two organisations.







The discussion about the SV right of veto was passionate with many members expressing their views about this power and the SV's rejection of all the agreements made in Lerma.

#### Some of the views put were:

- The SV board was not informed of the Lerma event, and this caused conflict; that the veto right is there for times of conflict.
- There was not enough discussion and communication from the WUSV, and it caused distrust.
- Better communication is needed.
- The new board needs to be given a chance to improve relations with member organisations.



In contrast, it was said that:

- The right of veto undermines democracy.
- There was legal basis for the changes to the statutes as agreed to in Lerma. A working group set up at the 2022 WUSV meeting drafted these changes.
- How can the WUSV move forward and ensure the new SV board doesn't reject agreements made at properly convened meetings? Certainty is needed, as is trust and respect.
- Building bridges is not vetoing agreements, it is blowing up the bridges!

#### **Outcome**

The proposal was withdrawn on the condition a clear commitment is given to investigate this matter. The president gave a commitment to find a solution and another working party will be established with members of the working party to be determined.

#### **Item 6.1**

Of significance for Australia is the proposal detailing two types of Excellent gradings. One is a WUSV Breeding Program GSD Excellent Grading and the other is a National GSD Excellent grading. Countries may choose which of the two systems apply, but not a mixture of both. This modification was approved and will be in effect on the next day of its approval.

"Excellent / Vorzüglich - WUSV" Dogs from the working dog classes who fully comply with the strictest requirements of the breed standard, who are self-confident and unconstrained, indifferent toward gun shooting, with a normal, almost normal or still admitted HD condition confirmed on the pedigree, with a normal, almost normal or still admitted ED condition confirmed on the pedigree, with a recognized trial title, and - if the animal is over the age of 3 ½ years - the first breed selection examination must have been successfully passed. Double premolars 1 are admitted.

"Excellent / Vorzüglich - National (name of the country)" Dogs from the working dog classes who fully comply with the strictest requirements of the breed standard, who are self-confident and unconstrained, indifferent toward gun shooting, with a normal, almost normal or still admitted HD condition confirmed on the pedigree, with a normal, almost normal or still admitted ED condition confirmed on the pedigree, with a breed survey examination, according to the national regulation, and - if the animal is over the age of 3 ½ years - the first breed selection examination must have been successfully passed. Double premolars 1 are admitted.

Each country may choose which of the two systems to apply, but not a mixture of both. This modification will be in effect on the next day of its approval.

The proposal to extend the time to fully comply with the HBP schedules was discussed and an alternative proposal suggested and accepted.

A matrix detailing the components of the HBP will be developed and distributed to member clubs for response. There will be no extension per se, however member clubs will be treated individually when assessing their ability to comply.



# **GSDCA Breeding Program Progress Report**

## **Our Organisation**

The German Shepherd Dog Council of Australia (GSDCA) is the overarching body that oversees the development, health and progression of the German Shepherd Dog and the personnel that work with the breed in Australia.

The GSDCA (Council) consists of 8 affiliate member clubs: 6 state clubs, 1 territory club and 1 regional club. The GSDCA is an affiliate of Dogs Australia (ANKC).

The Member Clubs that form the Council cater primarily for German Shepherd Dogs and are each affiliated with their recognised State or Territory Body, which controls canine affairs, and which may be admitted to membership as a Constituent Body by the Council (Table 1).

The president of each state club represents their club on the council. The Executive (Board) is elected by the members across Australia and serve a two-year term. The Council Executive comprises: President, National Breed Commission Chair, Secretary, Judges Committee Chair, Obedience Chair, Treasurer and Editor of the Council's magazine.

Decision making on significant matters in Australia is time consuming due to the constitution and democratic requirements of individual Member Clubs and the Council. Discussion and voting take place at each Member Club in each state and is then decided at the Annual General Meeting of Council. The voting strength of member clubs is set according to membership numbers and is scaled and capped. Decisions made at an Annual General Meeting come into effect from 1 July



(several months after the AGM) and a decision can-not be re-prosecuted for 2 years. The Executive body manages and directs the affairs of the council between meetings.

#### **Our Demographics**

Nationally the registration of purebred German Shepherd Dogs has declined from 13562 in 1986 to 3932 in 2010, and to 3503 in 2022. This is despite our human population growing. The number of dwellings has increased; however, backyard sizes have diminished in size (house covers most of the block of land) and there is much more apartment living in densely populated areas, making living space for GSDs quite limited.

We are a country of small breeders, with most animals being bred, sold as family pets. It is expensive to own a GSD in Australia. Most premium dog foods are imported, and costly, veterinary charges are considerable, for example, x-raying for HD ED could cost anywhere between \$500 and \$1000. (€300 to €600). Veterinary costs are extraordinarily high and registration costs keep rising.

Exhibitors and breeders travel long distances to mate their animals or to attend shows or trials. This is often on poorly maintained country roads. Access to air transport is limited and costly.

A minimum cost to air freight a dog one way would be \$500 (€300). All dogs must fly through a licenced cargo shipper and are charged by weight, inclusive of the crate. Places on planes are very limited. In some regional areas it is not possible to fly dogs as the planes do not support pet transport.

Our National Show and Trial will be held in Brisbane in 2025. To attend this event, it will take 2 or 3 days to drive from Melbourne; 5 - 7 days to drive from Perth and 3 or 4 days from Tasmania, including an overnight ferry trip. Flight times range from 2.5 to 4.5 hours, plus dogs must be checked in 90 minutes before the flight and it takes an extra hour at the end of the flight for collection



Affiliate clubs mostly located in or close to capital cities.



Size and distance comparison – Europe to Australia



Seven of the eight clubs are physically located in their State's or Territory Capital City. One club is based in regional New South Wales. The Victorian Club has 11 training locations. So, in total there are only 18 training locations in a country of 7.7 million square kilometres.

#### **Governing Body for Pure Bred Dogs in Australia**

Australian National Kennel Council Ltd (ANKC), trading as Dogs Australia (DA), is the peak body in Australia responsible for registered pedigreed dogs and co-ordinates its member bodies in each of Australia's eight states and territories.

Dogs Australia's mission is to promote excellence in breeding, showing, trialling, obedience and other canine related activities and the ownership of temperamentally and physically sound purebred dogs by responsible individuals across Australia. Dogs Australia is also responsible for providing education, examination and approval of Licenced Judges in Australia for All Breeds Groups and Single Breed Licence. Applicants must meet specific requirements including longevity of membership, breeding and ethics and club activity for their chosen breeds. The course for each of the 7 recognised groups from acceptance to approval for one group is approximately two years.



Single breed applicants must follow the same time frame as the group. Dogs Australia is an associate member of the FCI.

Breeders who are members of DA affiliates must abide by the Code of Ethics which covers extensive health and welfare considerations, including adequate maturity for first litter, maximum number of litters that can be bred from a bitch and that there must be adequate time to recover between litters.

The GSDCA is recognised by Dogs Australia as the National Breed Commission for the German Shepherd Dog in Australia.



#### **Features of the GSDCA Breeding Program**

The Australian Breeding Program consists of regulations and schemes administered by the GSDCA and Dogs Australia. It is also subject to National, State and Local Government laws covering canine welfare and control.

The following describe the features of the GSDCA's Breeding Program.

#### 1. GSDCA - Code of Ethics

Member Clubs and/or Officers of the GSDCA are expected to:

- Support the objectives of the National Council.
- Encourage our members, as owners and breeders of the German Shepherd Dog, to ensure that all dogs under their care are properly and appropriately cared for.
  - a) To comply with ANKC and State Canine Control "Codes of Ethics" as they apply.
  - b) To only breed with animals that are ANKC registered, German Shepherd Dogs.
  - c) To only breed with a bitch that is 18 plus months of age (as per ANKC ruling).
  - d) To only offer at stud a dog that is 18 plus months of age (as per ANKC ruling).



- e) The maximum number of studs any one dog may have will be limited to 90 per calendar year.
- f) The maximum number of litters any one bitch may have, be limited to 3 per 24-month period.
- g) To ensure that the sire and dam of the litter is successfully breed surveyed.
- h) To not allow puppies to leave their care before 8 weeks of age.
- i) To vaccinate all puppies for Distemper, Parvovirus, and Hepatitis by 8 weeks.
- j) To microchip the whole litter prior to leaving the kennels (as per ANKC ruling).
- k) To ensure that the whole litter is registered with the ANKC on either the Main or Limited register and that both varieties are correctly registered as such.
- I)To supply each purchaser of their puppies with literature regarding the raising, caring, and training of German Shepherd Dogs:
  - information relating to Member Club contacts in State or Territory of domicile of purchaser.
  - information relating to the GSDCA Breed Improvement Schemes
  - a 5-generation pedigree
  - an ANKC registration certificate for the puppy as sold.
  - an individual certificate of vaccination for the puppy as sold.
  - ensure the puppy is healthy at the time of leaving the member's care.
  - to microchip the whole litter and register prior to leaving the kennels (normally done at 6 weeks) of age and prior to leaving the premises.
  - [It is noted where the Canine Control regulation is more stringent then that will apply].
- Will not sell puppies through pet shops and/or weekend markets.
- Officers of the GSDCA will comply with the GSDCA Communication Code of Conduct.

#### 2. Positive Identification

Australia implemented a tattoo scheme in 1975 and it ran alongside the more recently introduced microchip scheme. Animal welfare lobbyists against tattooing and regulatory bodies in different states began to introduce regulations regarding the qualifications of personnel that could tattoo. This caused the Council to cease the tattoo scheme (2018) and rely on microchipping for positive identification, which by that time was mandatory for all registered dogs in Australia.

Dogs Australia has informed Canine bodies about its intention to introduce a DNA scheme. Dogs Qld (one state body) has introduced its own scheme for the registration of pedigreed dogs. All dogs registered in Queensland are required to be DNA tested. Dogs Qld's preferred DNA provider is Massey University (NZ), but members have the option to use Orivet. We believe that the markers selected are different to those required by the SV Scheme, however more owners are seeking to have their dogs completely profiled by Orivet. This uptake could lead to us being able to introduce a scheme in the future. A field has been set aside in the GSDCA Database for this to take place in the future.



#### 3. HD and ED Scheme

The GSDCA implemented an HD scheme in 1982 in conjunction with the University of Melbourne, Dr Roger Lavelle, and Dr Malcolm Willis (UK). Initially, a grading scheme like the SV system was used and the plates sent to the UK for scoring by the BVA scheme. Dr Willis devised the scoring system for the Australian scheme, based on pass and fail points. Since its inception over 12,000 animals have been submitted to the HD scheme (A stamp).

The GSD had become so popular in the 1980's after the lifting of the importation ban, and with many being sold as pets to Australian families, it was noted that far too many were presenting with issues in the elbows. The Council's research had highlighted the high heritability of elbow dysplasia in using affected animals and became proactive in introducing an Elbow scheme aligned with the HD Scheme (Z stamp) in 1991. The GSDCA conducts a Hip Dysplasia (HD)/Elbow Dysplasia (ED) Control Scheme to ensure that the breed average scores for hips and elbows for the German Shepherd Dog remain as low as possible. This in turn ensures that the soundness of the breed progresses. In 2022, 362 animals were presented to our scheme 346 gained an A stamp and 347 AZ.

HD Breed Average across Australia mean score = 9.5 GSDCA scheme median score = 8.5

ED Score 90% Normal GSDCA scheme

The GSDCA <u>Regulations Manual</u>, Section 3.3 details the procedure for x-raying, results, qualifications, re-submission of x-rays, appeals and the publication of statistics etc.

Once the Hip and Elbow x-rays have been received from the GSDCA's reader, a certificate is issued to the owner of the dog, explaining the scores achieved. The certificate also carries the GSDCA 'A' stamp and the 'Z' stamp to indicate that the dog has passed the HD/ED Control Schemes.

To ensure breeders are informed about our health schemes they can view data held on the GSDCA website or can use the member controlled GSDCA database.


GSDCA members can access the WUSV HDED Scheme via an online portal.

The GSDCA has negotiated a regulation with Dogs Australia to only register German Shepherd Dog puppies on the main register if both parents have passed an official Hip Dysplasia Control Scheme. Dogs must be positively identified by microchip prior to being x-rayed. Litters that do not meet the above requirements will be placed on the Limited Register and flagged not to be upgraded for breeding. Dogs on the Limited Register are not eligible for breeding. This Dogs Australia regulation, known as Litter Registration Limitation (LRL), came about by application from the GSDCA for all German Shepherds bred in Australia. #### 4. Breed Survey Scheme

Implemented in 1979, the GSDCA conducts a nationally accredited Breed Survey Scheme to recognise breed health, character, temperament and for advice regarding breeding. Over time the breed survey scheme has been improved in response to the growing need for (in particular) breed health. It is worth noting here, that any changes to our schemes are subject to the member clubs voting as per the constitution. The GSDCA Breed Survey scheme is tied to the Excellent grading. Animals that do not pass the health schemes, fail the gun test, or do not possess correct character and temperament assessments are not eligible to be breed surveyed; as a result, cannot be graded excellent at GSDCA recognised shows in Australia.

From 18 months of age to eight years, dogs can be presented to a panel of GSDCA Breed Surveyors to be assessed for their worthiness as a breeding prospect. Areas to be assessed cover temperament, character, gun sureness, anatomical attributes, movement, and general soundness. Major faults of temperament result in failure of the Breed Survey. Potential breeding partners are recommended according to the outcome of the survey. The object of having dogs presented to survey is to ensure the promotion of sound specimens for breeding as an aim to promote soundness of the breed in general. Successfully surveyed dogs are categorised as suitable for breeding that are far above or above average and are classified as GSDCA Breed Surveyed. The symbol of \* in front of a dog's name indicates that the dog has been successfully breed surveyed.

Generally, Affiliate Clubs hold four to five Breed Surveys throughout the year and a survey is held the day prior to a National Show. To participate in Breed Survey, the owner/applicant must be a member of an affiliated Member Club.

The following text and Table 4 presents data for the 2022 Breed Survey year 1 Jan - 31 Dec 2022

Thirty surveys were held between February and December 2022. A total of 162 animals were presented to survey this year, generating an income of \$3294: 73 % Stock Coat and the remaining 27%, Long Stock Coats. Dogs that could not be classified accounted for 8% of the total number of animals presented and almost half of those failed the gun test, with the remainder either oversize or lacking self-assurance throughout the survey and or the character test. One animal failed due to insufficient dentition. Four dogs were re-presented to survey throughout the year; three were successfully classified. See Table 4







#### Breed Survey challenges

Our established breed survey scheme has set high standards for its personnel. We are an ageing population, and it is encouraging to see that we have recently been able to welcome two new surveyors into the ranks in 2022 with a further three this year applying for the aspirant program. Currently we have 23 Breed Surveyors across Australia and 19 of them are over 60 years of age. There are less and less people coming forward to stand for positions in clubs and harmonisation expectations have divided the membership who already believe the systems in place are too costly and too tough.


Cost is a high factor as everyone volunteers their time and travel costs. The cost of survey for our members just barely covers the cost of administration to the scheme. Our rules require two surveyors to be present at every survey and if there are no resident surveyors in the state then the club and Council bear the costs. The cost can be high, providing services to remote members (refer to the map of Australia) and the locations of the clubs that are centred around the major cities. In NSW members regularly drive 6 hours just to be able to participate in breed survey. In Qld, Tasmania and WA, clubs hold surveys in conjunction with shows to try and keep costs down to offset expenses against the show. Often a second surveyor will be in attendance for the show and that keeps costs down also.

#### 5. GSDCA Show Gradings

The following Gradings are applicable:

- Excellent Merit: May be awarded at the judge's discretion, at State Breed Exhibitions ONLY.
- Excellent: May be awarded at the judge's discretion, to animals in the Open Class that are over 2 years of age and have successfully passed the GSDCA Breed Survey Scheme or a GSDCA recognised breed survey scheme.
- Very Good and Good: May be awarded at the judge's discretion, to animals in the Junior, Intermediate and Open Classes that are over 12 months of age.
- Very Promising and Promising: May be awarded at the judge's discretion, to animals in the Baby Puppy, Minor Puppy and Puppy Classes.
- Ungraded: At the judge's discretion if the judge considers the exhibit is unworthy of a grading.
- A gun test is required at shows where Excellent gradings are given.





#### 6. Specialist Judges and Breed Surveyors

To become a recognised GSDCA Specialist Judge able to critique and award the show gradings outlined above (p.14), an applicant must be in possession of their domiciled affiliate state canine body's judges' licence. (See p.3). As an approved Dogs Australia judge they can apply to join the GSDCA Specialist Judges Extension Scheme. This involves meeting the Council's specific criteria relating to successful use of the Breed improvement schemes including HDED, Breed Survey,



breeding of excellent graded stock and evidence of club participation. Applicants can usually complete this within 12 to 18 months and it involves mentoring sessions, critique writing, call out orders with approved judges, examinations at shows critiquing and grading of stock and a final examination phase during their own judging appointment judging a minimum number of dogs at GSDCA recognised events. Successful applicants are recognised at the National show each year. Aspirant GSDCA Judges pack

GSDCA Breed Surveyors are judges that have completed the GSDCA Extension Course, meeting additional criteria. They must apply to the Council to become an aspirant surveyor and be nominated by their club of domicile.

Over a twelve-month period, the aspirant Breed Surveyor acts as an apprentice surveyor at three separate surveys, working with a coordinator or senior surveyor, completing surveys, and justifying their decisions. After the 12-month period is complete the National Breed Commission mid-year meeting decides whether they have met the requirements and are ready to join the survey team.

GSDCA Specialist judges/surveyors have met a rigorous set of criteria to attain their status, and many have successfully judged abroad including New Zealand, Indonesia, India, Malaysia, United Kingdom, Pakistan, Scandinavia, and the United Kingdom.

#### 7. Specialist Shows

Specialist Shows are conducted by all Member Clubs against the official GSD standard. These Shows comply with the Dogs Australia rules with some additional requirements imposed by the GSDCA. For example, where possible the gun test will be conducted to gain an Excellent Grading in the Open Class. Only dogs who have been HD/ED tested and successfully Breed Surveyed can achieve an excellent grading. Knowledge of the dog's pedigree and identity is only permitted for judges at State Breed Exhibitions. These are judged on breed worth, progeny, and anatomy.

Regulations for Specialist Shows by a Member Club

- The Judge must be accredited German SV, SV Foreign list, GSDCA Specialist Judge, participants in the GSDCA Specialist Extension Course, or as approved by the GSDCA to judge Specialist GSD Shows, to award GSDCA Gradings and Medallions.
- If the Judge is German SV or WUSV, the Member Club will make application via the GSDCA Secretary and forward all fees for a clearance to be obtained from the SV (Section 2.3 Procedure for SV Judges Clearances).
- That non-SV judges from overseas be allowed to grade at championship shows if part of the signed contractual obligations is that they should comply with the rules and regulations as set by the GSDCA.
- That at all shows conducted by Member Clubs, and judged by German Shepherd Dog Specialist judges, there shall be an approved measuring stick, which has been annually checked by Member Club Officials, made available to the judge.
- All dogs and bitches must be measured in the Junior, Intermediate and Open Classes and the height and chest depth measurement be recorded in their critiques and the critiques forwarded to the NBC Executive after every show.

- That all Member Clubs forward to GSDCA Judges Committee Chair, in electronic form, the finalized critiques of each GSD Specialist Show. These will then be forwarded to the GSDCA NBC Executive by the GSDCA Judges Committee Chair.
- Member clubs must purchase the approved GSDCA medallions from the GSDCA for use at their Shows and Trials where GSDCA gradings are given, except for State Breed Exhibitions and West Coast Challenge Refer Awards Member Club Medallions, for exceptions.
- Gradings may be awarded at the discretion of the Judge according to the following:
  - o All Puppy Classes: Very Promising and Promising; Junior & Intermediate, Australian Bred & Open: Very Good, Good
  - Open Classes Only: Excellent grading and medallion may be awarded to animals over 2 years and have successfully passed the GSDCA Breed Survey Scheme or a GSDCA recognised breed survey scheme.
- If required, approved GSDCA Official interpreters must be used.
- A stenographer will be made available for the Judge.

#### 8. National Shows

Dogs Australia grants permission for the GSDCA to hold a National Show under their rules and regulations. The first (1967) and second (1972) National shows were held in Australia prior to the importation ban being lifted. The next two (1974 and 1976) were held two years apart. Since that time, National Shows have been held yearly except for 2020/21 during the Covid 19 pandemic. We celebrate our 50<sup>th</sup> National next year in South Australia in 2024.

Our largest entry for show and obedience was 1145 in 1979, with numbers holding steady around 800 until 2000. From that time, they have decreased in line with GSD registrations in Australia and, depending on the location, over the next 20 years have dropped to around 350 - 400 inclusive of show and obedience. These shows have almost entirely been judged by SV judges whose opinions are always highly valued by our exhibitors. The Sires progeny parade is also a highlight of every National as exhibitors from remote locations can view what the males are producing. A report of the progeny classes is prepared by the National Breed Commission Executive (NBC) and published in the Council's magazine.

This is the third time that Xaro's connections have presented a group at a GSDCA National Show and Trial. A further 45 puppies have been registered since the last national in 2017. Xaro's performance at GSDCA National Show & Trials has been outstanding, placing in the top 4 every year since 2015 Gnoze in 2016). This year the group consisted of 4 males and 5 females with two of the progeny exhibited in the Open classes rated Excellent with highly placed animals from Baby puppy through to Intermediate.

The group presented is of high quality with very good differentiation between the males and females. The animals are large, sire typical, well coloured and well pigmented, medium strong, substantial, of very good proportions, and of overall very good harmonious construction. Good heads and expression with dark eye colour and very good masking. Slightly large ears that should be slightly firmer in movement. The progeny show very good length of neck, withers, firm straight backs, quite well moulded croups that in some cases could be longer. The upper arm should be slightly longer and better angled with very good placement of the shoulder blade. Very good hindquarter angulation. Very good length of foreleg. They stand correct in front with balanced chest proportions. Very good fore-chest development, with good length of the lower chest. They step correct both front and rear with firm hock joints and good firmness of elbows. During movement they show very good ground covering gait with powerful hindquarter drive and very good forehand reach, with very good back transmission whilst displaying an excellent desire to run.

It is pleasing to see this sire present a group of high anatomical worth with animals displaying uniformity, very good overall construction, balance and free of exaggeration. This sire offers a high degree of predictability for breeders. Breeders can utilise Xaro to consolidate type, firmness, balance of construction and pigmentation. He is linebred on quality animals and proven producers. Care should be exercised with regard to size and the size and firmness of ears.

Xaro's progeny have returned excellent results through the GSDCA HD/ED scheme with 92% of progeny receiving normal gradings for elbows and a mean score of 8.4 for hips. A further 10 animals have successfully presented to the GSDCA Breed Survey Scheme this year bringing the total to 29.

Of particular note is the very good uniformity of the animals presented and reinforces that there is a very high degree of predictability when using Xaro to consolidate type, overall construction, hindquarter angulation and pigmentation. This is an excellent group and the NBC executive congratulate the connections of the sire on his achievements and encourage breeders to continue to utilise Xaro in their breeding programs.

At the height of the GSD popularity in Australia the Council, led by Louis Donald (retired SV Judge & President GSDCA 1976-1994) felt that as National Shows were unable to provide breeding advice, the concept of the Main Breed Exhibition (Australian Sieger Show) was borne. The MBE was designed to provide breed guidance across Australia and incorporated the results from State Breed Exhibitions, National and specialty shows and data from the Breed improvement schemes. The show attracted very good entries considering the distances people had to travel for two



"national type" shows in those years. The MBE enabled Australian breeders to establish a very good type of GSD based on soundness, character, temperament, predictability of family type and anatomy. An agility component was introduced for the Open classes in 1992.



The MBE ran yearly from 1987 - 1994 then bi-annually until 2003. By this time numbers had fallen to just over 200. An attempt to resurrect the MBE to yearly was made during both Vince Tantaro and Bruce Knight's tenures as president, however, the members decided to hold the last one in 2007 with an entry of 183. Numbers for the National show during that final period had remained consistently around 500 entries.

#### 9. State Breed Exhibitions (SBE)

The Aim & Purpose of a State Breed Exhibition

The State Breed Exhibition (SBE) prime function is to instil ideals, promote Breed Improvement Schemes and to add further to our goal of breed improvement, and therefore will be used as a tool that the Council can utilise to further educate the fraternity and for breeders to review the state of the breed within their own State on an annual basis. The SBE is the only show where the judge can have knowledge of the pedigrees and breeding of the dogs and are judged accordingly.

Primary Objectives of the State Breed Exhibition

The event will allow:



- For a comprehensive evaluation of the breed in each State on an annual basis.
- Breed direction that compliments the GSDCA Breed Survey Scheme and to give due recognition to animals that are of high anatomical worth, and or have proven that they can produce animals that are far or above average in terms of type and quality.
- Demonstrate the worth of major bloodlines, and more importantly the predictability when combined.
- GSDCA Specialist Judges and GSDCA Breed Surveyors an opportunity in addition to viewing Sires progeny parade at the GSDCA Nationals Show & Trial an avenue to assess the breed worth of a sire as a group.
- An opportunity for animals not presented at the GSDCA National Show & Trial Sires Progeny parade to present groups within their State.
- Further education of the fraternity / exhibitors through the judgments, commentary and summations as made by the officiating judges.

Age groups include 4-6 months, 6-9 months 9-12 months, 12-18 months, 24 months +

#### 10. Database

In the early 2000s the Executive of the Council discussions with the clubs recognised the need to provide an online information repository, using advancing technology and the rise in internet use. In 2007 a tender was sought to devise a database that would suit the needs of the GSDCA and required cooperation agreement with Dogs Australia (ANKC) to feed from the registrations of all German Shepherd Dogs bred in Australia each year. Between 2007 and 2010 the Council built the background pedigrees for the database. The database became operational in 2010 and fully integrated by 2014.

The GSDCA Database provides the GSDCA with a centralised system for the control of all areas of the GSDCA Breed Improvement Schemes and is available via the GSDCA website. The information contained in the GSDCA Database is copyright to the GSDCA, and always remains the sole property of the GSDCA.

This information can only be utilized/printed for personal use by members of GSDCA Member Clubs. Members access areas of the database, via login details issued by each Member Club.

#### 11. ZAP - Character Assessment

The GSDCA introduced a ZAP - Character Assessment evaluation for all dogs born after 1 January 2020. This is to engage young dogs with interactions and scenarios that will ensure they are prepared for future experiences. The test can be undertaken for all dogs 9 months - 8 years of age.

The test presently is voluntary, and assessments have taken place in most of the states with 68 animals entered in the database. Uptake is increasing as people embrace the importance of the need to assess German Shepherd character traits.

The Assessment aims to promote and offer guidance for the uniform development of the German Shepherd Dog Breed and to consolidate and ensure the character and temperament as part of the breed's inherent working qualities is maintained. It allows determination of behavioural characteristics and depending on the strengths/weaknesses displayed in each element, can be used in making future breeding decisions.


There are a variety of exercises which assess:


- General Disposition -during measuring and checking.
- Social Behaviour
- Noise Reactivity
- Movement Skills on unusual surfaces
- Play & Prey Drive
- Behaviours indoors
- Basic Character and disposition when left alone.

The various exercises are performed with the owner. The response and behaviour of the dog is recorded. It is based on the SV Character and Breeding Disposition Test.

The background work of creating a manual to support the implementation of the Character Assessment and results are now being recognised in Breed Surveys. Upon 'passing' the character assessment a GSDCA Certificate is provided to the owner and informs the Breed Surveyor. ZAP Character Assessment Information including a video demonstration.







#### 12. Dog Sport

Members can participate in wide range of Dog Sports. These activities are offered through their German Shepherd Dog club or local Obedience Club. Activities such as Agility, Tracking, Endurance, Herding, Obedience, Rally, Scent Work, Pack Dog and Trick Dog. This range of activities is not readily available consistently across the country and only exist where there are people participating locally and often with breeds of dogs other than German Shepherd Dogs.



Incorporating a working type of assessment into our breed improvement schemes is under discussion with the member clubs and Executive.

#### The Impact of Harmonisation on our Organisation

The majority of member clubs voted to remain affiliated with the WUSV/SV in 2022 and therefore our work remains to strive towards compliance with the schedules of the Harmonisation Plan. There is a growing understanding of the need to protect the breed from inbreeding and overtyping, including exaggerated construction, character, and temperament.

Australia has always felt a strong connection with the SV, its judges, and breeders; valuing the contribution they have made to the breed and our organisation. However, in recent years, there has been a mixed response from our member clubs regarding our ability to meet all the requirements of the Harmonisation program. This has caused considerable disunity at National Council level, with opinions about our capacity to meet the harmonisation schedules polarised.

There are a number of reasons for resistance to some of the harmonisation schedules:

- The expectation we would adopt regulations placed upon our organisation without consultation or agreement goes against the Australian psyche.
- The apparent lack of understanding or respect for the systems and structures already developed in Australia to support improved breed health.
- The lack of understanding of our laws and regulations relating to protection work, and our inability to comply with the IGP demands consistently across the country. In Victoria for example, any dog with an IGP title should be declared dangerous.
- An evident lack of understanding about the size of our country, the distances breeders and exhibitors are required to travel to access and pay for veterinary services, shows, surveys, training, and education.
- The infrastructure of our organisation resides mainly in the capital city of each state. Only the Victorian club has branches where members can train for show and various dog sports (tracking, obedience etc) in regional areas. Victoria is a perfect example where access to services, branches and trainers is boosted by it having a large population despite being geographically one of our smaller states. Therefore, it should come as no surprise its membership is 1000 more than the rest of the clubs in Australia combined.
- There is not a broad base of small local groups/branches, as there are in Germany, which make training easily accessible to all.
- The harmonisation program was viewed by some as dictates from an organisation that needed to look inward first and address the perceived dog dealing, cartel breeding and corruption within its own ranks.
- The expectation that Australians are expected to follow the German way is continuously challenged when it is apparent there are serious flaws in current systems abroad.
- Communication with the SV/WUSV has been problematic, with tardy responses to queries
  for clarification and guidance leading to frustration. This has created rifts within our own
  ranks as we attempt to maintain cooperation with the WUSV/SV.



#### Conclusion

The GSD fraternity in Australia is ageing. Despite declining numbers of registrations, the GSDCA Breed Improvement schemes have survived and are still attracting good percentages. With diminishing membership numbers there is a risk further attrition due to the perception of being dictated to by an organisation that, whilst in decline, has much greater access to training facilities and personnel than we could ever hope to have in Australia.

Despite all the limitations, Australia has a proven record and history of successful breeding and progression. SV judges that have judged here assure us that we are highly organised and that the character and temperament of our dogs are among the best in the world. They always have high praise for our organisation and administration of events where they adjudicate.

The GSDCA constitution dictates to our Council that the club members across Australia vote on changes to Council activities/schemes. Whilst that serves the democratic purpose from which the "Australian psyche" is built, it is difficult to make progress in environments where personal interest drives one's vote. Most members vote for how change affects them personally, rather than viewing the holistic need to maintain the GSD Standard. The Harmonisation platform has had a significant impact, dividing an already diminishing membership in Australia. Among other things, this is why it is difficult to initiate and act on change in Australia that does not involve some form of voluntary or opt in/opt out mechanism.

The GSDCA has built a strong foundation for maintaining the standard of the German Shepherd Dog. We have a proven record of continually striving to maintain the highest standard of breed health and anatomy. The current Continental Director, Heather McDonald judged our National show this year and can attest to the fact that the quality of Australian bred dogs exhibited at the show was high.
